NC Medicaid Managed Care has launched. Make sure you have the latest information and resources to help you with the transition.

Starting today, July 1, nearly 1.6 million Medicaid beneficiaries in North Carolina will begin receiving the same Medicaid services in a new way through NC Medicaid Managed Care health plans. Most beneficiaries will continue to get care from the same doctors they see today but will now be a member of a health plan. Some beneficiaries will not enroll with health plans and will remain in NC Medicaid Direct.

Join us **Thursday, July 8 from 2-3 p.m.**, to hear the latest updates on the state's launch of NC Medicaid Managed Care. There will also be an opportunity for questions and answers.
