Claims that require aggregation must be submitted to HHAeXchange.

**Home Health Services:** Home Health Services are currently under a soft launch and may be direct billed to Trillium’s Physical Health Portal without the EVV aggregator. However, it is recommended and encouraged to submit EVV visit information to HHAeXchange through the duration of the soft launch period to ensure all systems are operating as intended for a successful hard launch
